16 Oct. Noindex or unpublish the Oct 15 page. Friday Close stays.

20 Oct. Texas Q3 sales tax hangover is Kitchen's later cluster — still paused.

On-page

One H1. Niche + geography + the broken thing.

Title tag unique per page. 50–60 characters. County or Conroe in it.

First 80 words state the offer and the wall. Not a definition.

FAQ block matches the four PAA questions. Short answers. Named forms.

Internal link: cluster phrase → consult/close → Flow sample of that desk.

NAP: Montgomery County, Texas. No street until GBP is real. No fake pin.

Noindex preview, drafts, and the Extension page after the wall.

OFFICER

Blocked on the domain

These pages do not ship on a preview host. Buy the domain, claim GBP, then write the three H1s. This pack is the keyword script. The collaboration review is the cash calendar. They are not the same document.
